1. Purpose of This Addendum

To ensure a response, questions must be received in writing by **August 19, 2026 at 5:00 p.m. (Pacific Time)**. Responses to submitted questions will be provided by **August 24, 2026**, or the timeline may be adjusted if necessary.

To ensure fairness and avoid misunderstandings, all communications must be submitted in writing and directed only to the contact identified above. Verbal communications will not be considered and will not receive a response. All written communications must be submitted via email to the address provided.

All questions received by the deadline will be logged and reviewed. If necessary, responses will be issued through a written addendum to this RFP and distributed to all prospective applicants.

Agency is not responsible for, and shall not be bound by, any representations, statements, or explanations made by any individual acting or purporting to act on its behalf, other than LACAHSAs authorized representative(s) identified in this RFP. Any communication by applicants or their representatives—whether written or verbal—with any Board member, LACAHSAs committee member or Agency staff other than the designated contact indicated in this RFP, prior to contract award, is strictly prohibited and may result in disqualification from consideration.
